Every organization that qualifies for tax exemption as an organization described in section 501 (c) (3) is a private foundation unless it falls into one of the categories specifically excluded from the definition of that term (referred to in section 509 (a)). In addition, certain nonexempt charitable trusts are also treated as private foundations.

Private Foundations Private foundations are charitable organizations that do not qualify as public charities. In practice, they usually are nonprofits that were established with funds from a single source or specific sources, such as family or corporate money.

Grants for Private Christian Schools | Our Everyday Life

Nothing in this subchapter shall prohibit a religious organization, association, or society, or any nonprofit institution or organization operated, supervised or controlled by or in conjunction with a religious organization, association, or society, from limiting the sale, rental or occupancy of dwellings which it owns or operates for other than a commercial purpose to persons of the same ...

42 U.S. Code § 3607 - Religious organization or private ...

A private foundation is typically set up as a non-profit corporation that bears the name of its donors, but may alternatively be established as a trust. Donors specify the charitable purpose of the foundation (example: grants for cancer research, scholarships for the needy, support of religious goals) . During their lifetime, they may continue ...
